**EXTRACT FROM SPRC RULES:  
MEMBERSHIP**

- 3 (c) Ordinary Members shall consist of all persons who are at the date of passing these Rules Ordinary Members of the Club and all persons who are not less than twenty-one years of age and are elected to membership of the Club as Ordinary Members pursuant to Rule 6 and have paid an entrance fee. Persons shall not be elected as Ordinary Members of the Club unless they actively play polo with the Club or own and pay for at least a half share of a polo pony or amateur race horse or hack or have been Subscribing Members for not less than two years. In addition to an entrance fee, Ordinary Members shall pay a monthly subscription.
- (d) Subscribing Members shall consist of all persons of not less than twenty-one years of age who have been elected to subscribing membership of the Club pursuant to Rule 6. A Subscribing Member shall pay a monthly subscription and an entrance fee.
- (e) The Committee shall have power to elect Temporary Members, on such terms as they may determine, for any period not exceeding two months. The Committee shall endeavour to ensure that there shall not be at any one time more than twelve Temporary Members save that this limitation shall not apply to any person or persons participating in or associated with amateur race meetings and polo tournaments and other special occasions at the Committee's discretion. All such persons shall become Temporary Members unless the Committee otherwise decides. Save as hereinbefore provided every candidate for temporary membership shall be proposed by one Ordinary or Subscribing Member and seconded by a Committee member in writing and the proposal shall be handed to the Secretary. The proposer shall furnish the Committee with such information regarding the candidate as the Committee may require. Save in special circumstances as aforesaid the Committee shall proceed to the election of Temporary Members at their first meeting held after the expiration of forty-eight hours after receipt by the Secretary of such proposal and information. Temporary Members shall pay such fees and subscriptions as the Committee may determine.
